### <u>REPORT OF JAN S.H. CHOY, CPA REGARDING TRANSFER OF FUNDS TO QUALIFIED</u> <u>SETTLEMENT TRUST</u>

Pursuant to Haw. R. Civ. Pro. 53 and the October 30, 2023, Stipulation Regarding

Transfer of Class Settlement Amount to the Trustee and Amended Joint Order (the "Funds Transfer

Order") [Dkt. 1954], Jan S.H. Choy, CPA reports to the Court regarding transfer of funds as follows:

1. On October 31, 2023, at my request and direction, THREE-HUNDRED TWENTY-

SIX MILLION, THREE-HUNDRED FORTY-TWO THOUSAND, FOUR-

HUNDRED NINE and 43/100 DOLLARS (\$326,342,409.43)(hereafter referred to as

the "Settlement Fund"), was transferred by wire transfer from the Kalima Claims

Administration Cost Trust account (sometimes referred to as the Kalima Interim Costs



Fund) at First Hawaiian Bank to the Kalima Class Action Settlement Trust Dated 06232023 account (the "QST Account") at The Huntington National Bank, which account is controlled by Sylvius H. Von Saucken, General Manager - Mass Torts, EPIQ Class Action & Claims Solutions, Inc., Trustee of the Kalima Class Action Settlement Trust. Mr. Von Saucken was notified of the transfer in advance. The transfer was made to the QST Account, not Mr. Von Saucken directly, as it was a bank-to-bank wire transfer, and not a paper check. First Hawaiian Bank required use of the recipient account's bank routing number and account number.
