**SECOND SUPPLEMENT TO PROBATE SPECIAL MASTER'S
REPORT RE: PETITION FOR INSTRUCTIONS #19**

COMES NOW, EMILY H. KAWASHIMA, ESQ. ("Master"), duly appointed Probate
Special Master to examine the Petition for Instructions #19, filed March 3, 2025 (the
"Petition"), and respectfully submits this Second Supplement to Master's Report #19.

(C) **SETH NOAH UMIAMAKA**

Your Master received further updated information that there is another heir, Deborah Umiamaka, who is entitled to a share. Her identification has been confirmed and her birth certificate has been filed under seal.

Pursuant to HRS §560:2-103, under the laws of intestacy, when there is no surviving spouse, then the intestate share goes to the decedent's descendants in equal shares.

Paragraph 1-5.1(B)(3) of the QST instructs the Trustee to distribute the decedent's settlement to the heirs/ devisees of the deceased Class Member as "established by clear and convincing evidence as ordered by the Probate Court... following service of appropriate notice to the heirs and purported devisees."

On the basis of the foregoing, your Master amends her prior findings and recommendations and finds and recommends that this deceased class member's share of the *Kalima* settlement proceeds should be distributed as follows:

(P) **CALANTHE JOSEPHINE GOO**

The Court requested further information regarding the decedent as the biological mother of heir Eugene Goo. Eugene Goo's mother as reflected on his death certificate is "C. Donna Koanui," and not the decedent's name. Your Master learned, from the decedent's daughter, Eunice Goo, that Donna is Calanthe's nickname and not her legal name. Eunice believes that on

Eugene Goo's death certificate, the "C" in "C. Donna Koahui" is for "Calanthe." The Hawaiian Home Lands Claim Form also reflects that the decedent has an aka of "Donna." See Exhibit "5."

Your Master is satisfied that the decedent is the biological mother of Eugene Goo. On the basis of the foregoing, your Master's findings and recommendations remain the same.

(AA) MARGARET LEINAALA NG

Shortly after the hearing, your Master received and reviewed an agreement entered into by the decedent's heirs, attached here as Exhibit "6." Your Master finds that it appears to be validly executed and the family members did inform members of the Probate Plan team that they intended to submit this prior to the hearing.

Paragraph 1-5.1(B)(3) of the QST instructs the Trustee to distribute the decedent's settlement to the heirs/ devisees of the deceased Class Member as "established by clear and convincing evidence as ordered by the Probate Court... following service of appropriate notice to the heirs and purported devisees."

Based on the submission of this distribution agreement, your Master amends her previous findings and recommendations and finds and recommends that this deceased class member's share of the *Kalima* settlement proceeds should be distributed as follows:
