**FIRST SUPPLEMENT TO PROBATE SPECIAL  
MASTER'S REPORT RE: PETITION FOR INSTRUCTIONS #21**

COMES NOW, EMILY H. KAWASHIMA, ESQ. ("Master"), duly appointed Probate Special Master to examine the Petition for Instructions #21, filed May 27, 2025 (the "Petition"), and respectfully submits this First Supplement to the Report.

**(W) ANNA MARIA LEIMOMI KAUI PINEDA**

Your Master spoke to the decedent's daughter, Marice Pineda. She stated that her mother did not have a Will or Trust and that she and her sibling are the only descendants of the decedent. However, she then informed that she was appointed as the Executor of her mother's estate in

California. Your Master requested a copy of any documentation showing the probate in California, but was not provided with anything prior to this filing.

On the basis of the foregoing, your Master does not amend her prior findings and recommendations unless further documents are submitted.

**(AA) KENNETH K. ROSA**

Your Master reviewed the facts contained in Petition #21, as well as the data provided in the Facilitator database. The decedent's death certificate lists marital status as Married to Jennie K. Kaio, also known as Jennie Rosa. There was no will or trust submitted. Your Master received correspondence from the decedent's daughter, Samalyn Nani Rosa, who confirmed that her father did not have a will or a trust. She also shared that her mother, Jennie Rosa, died on August 31, 2024.

Samalyn was not able to provide a death certificate. Your Master located an obituary which was attached as Exhibit "4" in her Report filed on June 13, 2025. The obituary states that Jennie Kapulani Rosa was survived by Ronnie Secritario, Spencer Secritario, Diane Miguel, Charmain Nuuanu, Jo Buresh and Samalyn Rosa. There was no mention of Arthur Rosa or Robert Rosa.

Your Master again contacted Samalyn Rosa who explained that her mother was married to Jose Secritario and had six children before she married Kenneth Rosa. Of the six children, Hiiakaonamoku Wong is deceased. Hiiakaonamoku Wong died without a surviving spouse but is survived by her daughter, Kathleen Wong, who is not a minor. Diane Miguel, Charmaine Nuuanu, JoSandra Buresh, Ronnie Secritario, and Spencer Secritario survived their mother, Jennie. Robert and Arthur are Kenneth Rosa's children from his first marriage and Jennie did not legally adopt them. Samalyn is the only child of Kenneth and Jennie Rosa.

Pursuant to HRS §560:2-103, under the laws of intestacy, when there is no surviving spouse, then the intestate share goes to the decedent's descendants in equal shares. Jennie Rosa, as the surviving spouse, was entitled to the settlement proceeds. Pursuant to HRS §560:2-102, since one or more of the decedent's surviving descendants are not descendants of the surviving spouse, the surviving spouse would be entitled to receive the first of a certain dollar amount. Your Master has confirmed that the settlement award does not exceed that amount.

Your Master finds and recommends that this deceased class member's share of the *Kalima* settlement proceeds should be disbursed to the estate of the decedent's surviving spouse.

Paragraph 1-5.1(B)(3) of the QST instructs the Trustee to distribute the decedent's settlement to the heirs/ devisees of the deceased Class Member as "established by clear and convincing evidence as ordered by the Probate Court... following service of appropriate notice to the heirs and purported devisees."

On the basis of the foregoing, your Master finds and recommends that this deceased class member's share of the *Kalima* settlement proceeds should be distributed as follows:
